## **6. Public Speaking**

- a) A period of not more than 10 minutes will be made available for members of the public and Members of the Council to comment on any matter. Where a member indicates they have a prejudicial interest, but wish to make representations regarding the item before leaving the meeting, those representations must be made under item (c) below. (If the item to which representations of comment were made by a Member is on the Agenda the Member must declare again and withdraw from the meeting during consideration of the item).
- b) If the Police Liaison Officer, a County Council or District Council Member is in attendance they will be given the opportunity to raise any relevant matter. Members of the Council, however, will restrict Police matters they raise to those relating to their Council Ward.
- c) Members declaring an interest other than a Disclosable Pecuniary Interest who wish to make representations or given evidence under the National Association of Local Councils' (NALC) Code of Conduct relating to Agenda items shall do so at this stage.
